Program Services & Childhood Health Committee Meeting Summary of Actions Taken January 6, 2022 3:30 p.m.

These actions were taken by the Program Services & Childhood Health Committee meeting held on January 6, 2022, with a quorum of members physically present and some members attending virtually:

*Please note that the number of board members fluctuate based on arrival and departure of some of them throughout the meeting.

Motion to approve the November 4, 2021 Program Services & Childhood Health Committee meeting minutes was made by Mary Donworth and seconded by Lourdes Gimenez. Motion passed unanimously, 7-0.

Resolution 2022-A: Motion to recommend the resolution to the Board of Directors on January 18, 2022 was made by Annie Neasman and seconded by Dr. Daniel Bagner. Authorization for a procurement waiver from the formal competitive procurement process to award a total amount not to exceed \$25,790,000.00 for the delivery of child care quality improvement services described below. The total amount breaks down to \$14,300,000.00 to negotiate and execute multiple contracts with providers, identified herein, and for The Children's Trust to encumber purchase orders in the amount of \$11,490,000.00 for educator scholarship payments, salary supplement payments to early learning educators, and high-quality tiered payment differentials to providers, for a term of 12 months, commencing October 1, 2022, and ending September 30, 2023. Motion passed, 10-0. Recusals by Mary Donworth and Pamela Hollingsworth.

Resolution 2022-B: Motion to recommend the resolution to the Board of Directors on January 18, 2022 was made by Lourdes Gimenez and seconded by Annie Neasman. Authorization to negotiate and execute contracts with the Early Learning Coalition of Miami-Dade/Monroe, Miami-Dade County Community Action and Human Services Department, and the United Way of Miami-Dade, for local match funding for the federal Early Head Start-Child Care Partnership (EHS-CCP) grant, in a total amount not to exceed \$2,270,000.00, for a term of 12 months, commencing October 1, 2022, and ending September 30, 2023. Motion passed, 11-0. Recusals by Mary Donworth and Pamela Hollingsworth.

Resolution 2022-C: Motion to recommend the resolution to the Board of Directors on January 18, 2022 was made by Dr. Dorothy Bendross-Mindingall and seconded by Pastor Richard Dunn. Authorization to negotiate and execute a contract with Redlands Christian Migrant Association (RCMA) for local match funding to draw down federal-state funds to subsidize child care for the working poor, in a total amount not to exceed \$102,000.00, for a term of 12 months, commencing October 1, 2022, and ending September 30, 2023. Motion passed unanimously, 14-0.

Resolution 2022-D: Motion to recommend the resolution to the Board of Directors on January 18, 2022 was made by Mary Donworth and seconded by Annie Neasman. Authorization to negotiate and execute a contract with the Early Learning Coalition of Miami-Dade/Monroe (ELC) for local match funding for the State of Florida School Readiness Program Match (formerly known as Child Care Executive Partnership) grant, in a total amount not to exceed \$1,230,000.00, for a term of 12 months, commencing October 1, 2022, and ending September 30, 2023. Motion passed, 13-0. Recusal by Pamela Hollingsworth.

Resolution 2022-E: Motion to recommend the resolution to the Board of Directors on January 18, 2022 was made by Lourdes Gimenez and seconded by Dr. Dorothy Bendross-Mindingall. Authorization to negotiate and execute a contract with the University of Miami-Nova Southeastern University (UM-NSU) Center for Autism and Related Disabilities (CARD) for autism spectrum disorders (ASD) diagnostic evaluation services, in a total amount not to exceed \$264,000.00, for a term of 12 months, commencing October 1, 2022, and ending September 30, 2023. Motion passed unanimously, 14-0.

Resolution 2022-F: Motion to recommend the resolution to the Board of Directors on January 18, 2022 was made by Dr. Daniel Bagner and seconded by Lourdes Gimenez. Authorization to negotiate and execute contract renewals with six providers, identified herein, to deliver comprehensive school-based health services, in a total amount not to exceed \$16,250,000.00, for a final term of 12 months, commencing July 1, 2022, and ending June 30, 2023, subject to funding appropriations; and also, to request authorization to use funds from this initiative to leverage federal funding through the Low-Income Pool program (LIP). Recommended Action: Authorization to negotiate and execute final contract renewals with

81 providers identified herein, to deliver high-quality after-school programming for 12,197 elementary school children and summer programming for 13,125 elementary school children, in a total amount not to exceed \$36,090,190.00, each for a term of 12 months, commencing August 1, 2022, and ending July 31, 2023, for year-round and school-year programs, subject to annual

funding appropriations.

Budget Impact: Funding in the amount of \$36,090,190.00 for this resolution is

allocated for FY 2021-22 and is projected to be available in FY

2022-2023.

Description of Services: The Children's Trust provides after-school programs and summer camps for elementary school-aged children (grades K-5) in inclusive and specialty disability programs. A program is considered inclusive if 10 percent or more of the students enrolled report living with a disability. Programs operate five days per week (Monday-Friday). After-school programs follow the Miami-Dade County Public Schools calendar (180 days). Based on specific funding applications, programs may also operate full days on teacher planning days, holidays, and spring break. Summer programs operate at least 10 hours per day for six to 11 weeks.

Programs follow a structured schedule of activities to support academic success, social-emotional learning (SEL), and physical fitness. There is a focus on reading fluency in grades K-3, with a shift to reading comprehension in grades 4-5. Evidence-based group literacy strategies and differentiated (individualized) small group reading instruction by certified teachers for children struggling with reading are utilized. Homework assistance is provided during the school year. SEL is focused on developing essential competencies and life skills. Fitness components aim to help children meet the recommended levels for high-intensity physical activity. Children receive nutritious food and beverages, and programs incorporate family engagement. Additional skills-building activities vary across programs and may include:

- STEM (science, technology, engineering, math)
- Arts and culture
- Civic engagement
- Specialized programming for children with disabilities.

One Contract with Grace Christian Preparatory, Inc. in the amount of \$159,401.00 is not being recommended for renewal due to ongoing programmatic issues, including DCF licensing.

Background: On May 29, 2018, The Children's Trust board approved the funding recommendations from the competitive request for proposals, RFP# 2018-02, for a five-year funding cycle, following a comprehensive review process. To date, programs have been successfully renewed based on their performance and participants' needs. The most recent program performance ratings available, from before the COVID-19 pandemic (in January 2020), indicate 92 percent or more of programs were performing at or beyond contractual expectations.

We are currently in the fourth year of the funding cycle (2021-2022), and our programs have continued to adapt effectively to the evolving crisis caused by the COVID-19 pandemic. Programs continue to follow the Centers for Disease Control (CDC) guidelines, and we have seen minimal program closures during this contract year.

Current recommendations for renewals for the fifth and final year of the funding cycle (2022-2023) are based on staff assessment of programs through several site visits to observe activities. Program observations show that providers are offering high-quality, individualized services to meet families' needs. In-person services are operational, while maintaining child and staff safety following CDC guidelines. Programmatic data for the first six months of programming (August 2021 through January 2022) are summarized in the attachment.

Description of Services: The Children's Trust provides after-school programs and summer camps for middle and high school youth (grades 6-12) in inclusive and specialty disability programs. A program is considered inclusive if at least 10 percent of the students enrolled report having a disability. School-year programs engage youth for at least 50 days over no less than 36 weeks, with a minimum of 150 individual contact hours over the school year. Year-round programs offer both after-school and summer activities. Summer programs operate for no less than six weeks, with a minimum of 90 contact hours per youth. Summer programs may provide shorter service intervals for youth of at least 15 days of service, as long as contact hours are met.

Programs follow a structured schedule of activities to support academic success, socialemotional learning (SEL) and skills-building in one or more specialized areas. Many programs also include family engagement activities. The specialized areas include:

- STEM (science, technology, engineering, math)
- Arts and culture
- Civic engagement
- Sports
- Job training/coaching
- Entrepreneurship
- College readiness
- Family engagement activities.

One agency, Shepherd of God Academy Corp., elected not to move forward with contract renewal and the award of \$115,033.00. Additionally, Miami-Dade County (Community Action and Human Services Department) elected to reduce service numbers from 57 to 40 and the contract amount was reduced proportionally. The contract reduction was \$53,648.00.

Background: On May 29, 2018, the board of The Children's Trust approved the funding recommendations from the competitive request for proposals, RFP# 2018-02, for a five-year funding cycle, following a comprehensive review process. To date, programs have been successfully renewed based on their performance and participants' needs. The most recent program performance ratings available, from prior to the COVID-19 pandemic (in January 2020), indicate 90 percent or more of programs were performing at or beyond contractual expectations.

We are currently in the fourth year of the funding cycle (2021-2022), and our programs have continued to adapt effectively to the evolving crisis caused by the COVID-19 pandemic. Programs continue to follow the Centers for Disease Control (CDC) guidelines, and we have seen minimal program closures during this contract year.

Current recommendations for renewals for the fifth and final year of the funding cycle (2022-2023) are based on staff assessment of programs through several site visits to observe activities. Program observations show that providers are offering high-quality, individualized services to meet families' needs. In-person services are operational, while maintaining child and staff safety following CDC guidelines. Programmatic data for the first six months of programming (August 2021 through January 2022) are summarized in the attachment.

Background: Despite the coronavirus (COVID-19) pandemic's disruptions to the past two school years and last summer, our Youth Development programs continue to serve students with innovation and flexibility. While most of our programs offered continuous in-person services during the 2021-22 school year, additional programmatic implementation costs were incurred, such as funding to address staffing shortages and security costs.

The Trust conducted a survey with all Youth Development providers to understand the fiscal impact of the pandemic on day-to-day program operations. Twenty programs responded indicating that they had additional needs that could not be covered within their existing budget. Staff met with each of the providers to review current budgets to determine if the need could be met without additional funds. As a result, the funding increases identified in the table above for 13 contracts are recommended. These numbers align with the budget analysis conducted by staff based on providers' historical expenditures and their unit costs.

Description of Services: The Children's Trust provides funding for after-school programs and summer camps for elementary school children (grades K-5) in inclusive and specialty disability programs. Inclusive programs engage 10 percent or more children with disabilities. Programs operate five days per week (Monday-Friday). After-school programs follow the Miami-Dade County Public School calendar (180 days). Based on specific funding applications, programs may also operate full days on teacher planning days, holidays, and spring break. Summer programs operate at least 10 hours per day for a period of six to 11 weeks.

Programs follow a structured schedule of activities to support academic success, social-emotional learning (SEL), and physical fitness. There is a focus on reading fluency in grades K-3, with a shift to reading comprehension in grades 4-5. Evidence-based group literacy strategies are utilized, along with differentiated (individualized) small group reading instruction by certified teachers for children struggling with reading. Homework assistance is provided during the school year. SEL is focused on developing essential competencies and life skills. Fitness components aim to help children meet the recommended levels for high-intensity physical activity. Children receive nutritious food and beverages, and programs incorporate family engagement. Additional skills-building activities vary across programs and may include:

- Arts and culture
- Civic engagement
- Specialized programming for children with disabilities.

Strategic Plan Headline Community Results: Children are ready for kindergarten, and students are succeeding academically.

Recommended Action: Authorization to negotiate and execute a contract renewal with

Florida International University Board of Trustees (FIU) for reading enhancement services, in a total amount not to exceed \$882,168.00, for a term of 12 months, commencing October 1, 2022, and ending September 30, 2023, with one remaining 12-

month renewal, subject to annual funding appropriations.

Budget Impact: Funding in the amount of \$882,168.00 for this resolution is

projected to be available in FY 2022-2023.

Description of Services: The FIU Reading Explorers program provides reading enhancement services to existing Trust-funded after-school and summer programs and Trust-affiliated early childhood education programs. FIU delivers literacy interventions directly for young children attending these programs during the summer. During the school year, Reading Explorers provides on-site coaching and support to assist after-school program staff in the delivery of effective differentiated (individualized) literacy instruction (DLI).

Summer services are the most intensive and include:

- pre/post reading assessments for children entering kindergarten, first and second grades to identify children in need of individualized reading intervention beyond what is typically provided by Trust-funded summer camps and affiliated early childhood education programs;
- 2) small-group tutoring services (with no more than five children, four days per week for 30-45 minutes per session, led by certified teachers) for struggling readers and pre-readers using an age-appropriate, evidence-based curriculum;
- 3) parent involvement activities to engage families in supporting literacy skills at home, including book giveaways; and
- 4) referral connections to Miami-Dade County Public Schools for additional school-year services, when indicated.

School-year services include on-site collaborative coaching, observation, and consultation for Children's Trust-funded after-school program staff to ensure the delivery of high-quality, evidence-based DLI.

Background: As part of The Children's Trust efforts to reduce summer learning loss, reading enhancement services have been funded by The Children's Trust since 2013, starting with summer reading services. During the second funding cycle, 2016-2018, the program was expanded year-round to include after-school staff coaching and consultation during the school year.

On February 19, 2019, The Children's Trust board approved the funding recommendation from the competitive request for proposals, RFP# 2019-03, to fund one agency with

demonstrated expertise to provide reading enhancement services, for a five-year funding cycle. Through the competitive solicitation process, FIU demonstrated its capacity, expertise, and qualifications to continue providing the services. Contract performance has consistently met or exceeded expectations for numbers served and participant outcomes.

In the summer of 2021, Reading Explorers coaches supported the planning, virtual hosting, and materials distribution for the third annual Battle of the Books event, which engaged more than 800 participants virtually from 16 summer camps and distributed more than 16,000 books to children across six weeks of events. Additionally, Reading Explorers provided high-quality literacy intervention services to seven Thrive by 5 early learning programs and 39 Trust-funded summer camps. Seven hundred and forty-nine children who were struggling with reading received in-person literacy intervention, receiving an average of 17 sessions throughout the summer.

From August 2021 to January 2022, 62 after-school program staff at 20 sites received 125 hours of coaching and consultation to improve their delivery of DLI. Coaching hours varied by location depending on site needs and mutually developed coaching support plans. Topics included: improving adherence to recommended instructional time (DLI and whole group literacy), enhancing the reading environment, providing high-quality teacher modeling and feedback, improving student engagement, incorporating active fluency and comprehension strategies into reading time, and using reading fluency pre-test data for DLI grouping.

As in previous years, to assist with DLI implementation, literacy kits containing 42 lesson plans and related instructional materials from the Florida Center for Reading Research in convenient storage bins were distributed to after-school literacy teachers. Sites serving large populations of English as a Second Language (ESL) learners were provided with ESL resource workbooks. Based on the needs of providers to date for 2021-22, four literacy kits and 300 books were provided to after-school programs receiving consultation services. Coaching recipients are highly satisfied with the reading enhancement supports.

Recommended Action: Authorization to negotiate and execute a contract with Florida

Introduces Physical Activity and Nutrition to Youth (FLIPANY) for after-school snacks and meals, in a total amount not to exceed \$600,000.00, for a term of 12 months, commencing October 1, 2022, and ending September 30, 2023, with three remaining

contract renewals.

Budget Impact: Funding in the amount of \$600,000.00 for this resolution is

projected to be available for FY 2022-2023.

Description of Services: Through partnerships with the Florida Department of Health (DOH) and the Florida Department of Agriculture (FDA), FLIPANY provides nutritious lunches, snacks, and suppers to 78 Trust-funded after-school sites for children and youth in grades K-12. In addition to food distribution, FLIPANY offers administrative services to these agencies to help them meet the requirements of the Afterschool Meals Program funded by the FDA and administered by DOH.

The Children's Trust requires all after-school and summer programs to provide participating children with food that meets the United States Department of Agriculture (USDA) nutrition program requirements. FLIPANY is the after-school snack and meal provider for programs not located in a Miami-Dade County Public Schools or a licensed child care center. FLIPANY delivers healthy snacks to after-school providers weekly based on the average number of snacks consumed in the prior week.

Additionally, an increasing number of sites are now serving evening suppers daily. This service is highly rated by the children and the staff and is available as a hot or cold meal. FLIPANY encourages providers to serve evening suppers to ensure that basic nutritional needs are met.

During the first four months of the current contract, FLIPANY:

- provided 102,748 snacks and 42,368 suppers/lunches, which resulted in \$257,814.88 in leveraged federal reimbursement and
- received positive reviews from site staff indicating that students were extremely satisfied with the food choices and after-school staff were extremely satisfied with snack delivery and quality.

Background: After-school sites with children who meet free and reduced-price lunch criteria or within school boundaries that include children who meet the requirements are approved by the DOH for federal reimbursement. FLIPANY assists sites in getting approved for reimbursement by the DOH. During the last contract year, 54 new sites were approved by the DOH; and during the current contract year an additional nine sites were approved. The Children's Trust uses rates established by the DOH Child Care Food Program as a guideline for the cost of meals per participant and will not reimburse at a rate greater than the established reimbursement rates, with the exception of supper, which is reimbursed at a rate of \$4.93. The Children's Trust pays for snacks, meals, beverages, and food administration at sites that do not meet the DOH requirements.

On February 8, 2021, The Children's Trust released Request for Qualifications (RFQ) #2021-05 for one agency to act as the After-school Meals Program Food Sponsor. One application was received, reviewed, and recommended for funding. FLIPANY has been providing snacks and meals to Trust-funded providers since June 2015. FLIPANY has demonstrated that it has the established infrastructure and capacity to continue this critical nutrition component, supporting the health and development of participating children and youth.
