Further, delegation of authority to adjust paid partners based on the needs of funded programs. (*Pgs. 5-7*)

Description of Services: Trust Academy partners provide supports for quality program implementation and sound fiscal and administrative functions. Partner agencies support The Trust's service providers in their efforts to build strong, sustainable organizations that consistently deliver high-quality services in alignment with best practices and healthy child development. The Children's Trust's mission is accomplished through its contracted service providers. We aim to support service providers to:

- achieve meaningful, measurable results for parents, children and families;
- consistently deliver high-quality services in alignment with best practices; and
- effectively and efficiently satisfy Trust contractual expectations.

Trust Academy offers a coordinated collection of learning and quality improvement supports tailored to strengthen organizational capacity, program quality, and positive staff-participant interactions to provide Trust-funded programs with better opportunities to achieve more sustainable and meaningful results for children, families, and staff.

Trust Academy program quality supports are critical to the success of The Trust's strategic framework. Through developing and delivering online courses, live trainings, peer learning and coaching, Trust Academy partners support the direct service and management staff of funded provider agencies across various Trust-funded initiatives. Trust Academy partners also closely collaborate to coordinate supports. The Trust Academy partners conduct community awareness and outreach and provide planning and policy supports related to the funding area and program initiatives supported by the Trust, including:

- Family Services: Family & Neighborhood Support Partnerships and Parenting Programs
- Youth Development: Elementary, Middle and High-school After-school and Summer Programs
- School-based Oral Health: Nurse Training

- Inclusion Supports for Programs Serving Children and Youth with Disabilities
- Social and Emotional Wellness (SEW) / Racial Equity, Diversity and Inclusion (REDI)
- Organizational Capacity and Leadership Development: Capacity supports for selected Trust-funded organizations (across all initiatives), Small community-based organizations (CBO) capacity building, and Program Management Leadership Academy

Reason for Waiver: Resolution No. 2023-52 authorized paid partner Aqua Foundation. Following contract negotiations, YWCA made the business decision to replace Aqua Foundation with Equality Florida who will be providing the same service that was awarded in the original RFP

Background: On June 13, 2022, the board of The Children's Trust approved the funding recommendations from the competitive Invitation to Negotiate (ITN) 2022-02 to fund Trust Academy quality support partners for a five-year cycle with one-year contract renewals, following a comprehensive review process.

Overall performance has met expectations. The following chart displays the number of events and participants across all Trust Academy offerings during fiscal year 2022-23:

Budget Impact: Funding in the amount of \$535,000.00 for this resolution is

projected to be available in FY 2024-2025.

Description of Services: Sound organizational support and staff competencies are best for implementing and maintaining high-quality programs. Throughout Miami-Dade County, small organizations provide services that respond to the community's needs, and organizational development supports can increase their impact.

Learning and quality improvement supports, and small CBO capacity building more specifically, are important to the success of The Trust's strategic framework. Each small CBO participating in this two-year initiative receives a funding award for individualized programmatic and fiscal capacity-building. The 15 small CBOs listed below will engage in several capacity-building activities supporting the successful implementation of each CBO's capacity building plan. Funding awards support capacity building needs and do not fund direct service functions. Activities include, but are not limited to, time allocated for:

- organizational assessment, training, on-site coaching, and networking opportunities.
- infrastructure, staff, and board development.
- additional training.
- administrative functioning.
- marketing and resource fund-development materials and activities.

The Children's Trust's staff, with coordination support by The Pontis Group (the Trust Academy contracted partner for Organizational Capacity and Leadership Development), ensure that the program is executed in alignment with its goals of supporting small CBOs to:

- deliver high-quality, evidence-based services with fidelity.
- practice strong administrative and fiscal management.
- engage in continuous learning and quality improvement.
- foster financial sustainability, including seeking revenue from diverse sources.
- advance parent and community engagement, along with resident advocacy.

During year one of the initiative, CBOs completed self-assessments to identify individualized areas in which to build acumen. Coaching was offered and facilitated for the leaders of participating CBOs for the completion of the assessment and in the development of capacity

building plans that continue from the first year of funding into the second year of funding, if approved. CBOs focus capacity building in the following areas:

- Board development and executive leadership.
- Strategic planning.
- Resource development and fundraising.
- Effective management of people.
- Program quality, including design, implementation, and monitoring/evaluation for continuous learning.
- Community engagement, community cultural sensitivity, and collaboration.
- Communications.
- Fiscal capacity building services.

Leadership development and the development of adaptive capacities are infused within all the activities.

Background: Starting in 2015, the board addressed the need to provide capacity building for small CBOs. The Children's Trust completed the inaugural Small CBO Capacity Building cohort in July 2018. Another cohort was selected and implemented from April 2019 through March 2021. This is the third cohort which began in October 2023.

For the purposes of this initiative, eligible small CBOs are defined as:

- having a current annual operating budget between \$50,000 minimum (including the value of in-kind goods and services) and \$500,000 maximum (excluding the value of in-kind goods and services);
- providing services to children and families that address identified community needs, especially those supporting agencies that serve children and families living in neighborhoods impacted by high poverty rates, as well as those serving special populations like children with disabilities, experiencing homelessness, involved in dependency or juvenile justice systems, or LGBTQ (Lesbian, Gay, Bisexual, Transgender or Questioning) youth;

- being a non-for-profit organization with continuous operations for at least two years;
- not previously completing the two-year Small CBO Capacity Building initiative, and not having current Trust board-approved contracts, with the following exceptions, which are considered eligible:
 - Agencies currently or previously subcontracted within a Trust contract;
 - Agencies currently or previously funded for only an Innovation Fund Trust contract;
 - Agencies currently or previously funded through Trust community engagement and outreach funding; and
 - Agencies with previous (but no current) Trust board-approved contracts.

The funding award amount varies according to the agency's annual operating budget at the time of solicitation application (excluding the value of in-kind goods and services), as indicated below:

The Children's Trust issued a competitive request for proposal, RFP 2023-11, on April 3, 2023, to fund capacity building supports for child and family-serving small CBOs in Miami-Dade County. Sixteen applicants for capacity-building of small CBOs were recommended for funding because of the RFP review process, for a total annual amount of \$595,000.00. One organization, Parks Foundation, Inc., did not accept the award in year one due to the resignation of its Executive Director. The fifteen organizations that participated in the initiative's first year are recommended for renewal, in a total annual amount of \$535,000.00.

Description of Services: This resolution authorizes match funding for the Miami-Dade County Department of Cultural Affairs (County) to support non-profit organizations that provide cultural arts programs for children and families across Miami-Dade County. The County issues competitive grant opportunities throughout the year and provides at least 100 percent leveraged funding for these youth arts education programs. Grant applications are reviewed and rated by experienced community members with expertise in the arts and staff members from The Children's Trust. Funding for programs awarded through this grant process is limited to youth development programs that The Children's Trust has not already funded.

The County works with The Children's Trust to develop appropriate tracking and outcome measures for funded programs to ensure program and participant progress and quality improvement. The three program areas of cultural arts education and enrichment that are funded include:

1. YOUTH ARTS ENRICHMENT PROGRAM (YEP)

YEP enriches the lives of children by making the arts available to more children and families throughout Miami-Dade County through:

- arts instruction;
- arts intervention;
- · in-school and public performances;
- healing and expressive arts; and
- public exhibitions.

2. All KIDS INCLUDED (AKI): ACCESSIBLE ARTS EXPERIENCES FOR KIDS

AKI's mission is to increase the number of quality arts experiences accessible to children with disabilities and their families and to promote the benefits and importance of inclusionary arts and cultural programs in school settings and the community. This program makes resources available to non-profit organizations, including funding, ideas, information, technical assistance, and programs. Funding creates ADA-accessible arts experiences for children and youth with disabilities, which affords all children the opportunity to participate fully in the arts. Project-based funding is provided in two categories: demonstration projects to create high-profile, innovative, fully accessible arts experiences; and programs using the arts as learning tools to help teach program staff how to include children with disabilities in the classroom and community.

3. SUMMER ARTS & SCIENCE CAMPS FOR KIDS (SAS-C)

The objective of SAS-C is to provide grant funding to non-profit organizations that offer children across Miami-Dade County high-quality cultural arts and/or science summer camps at little or no cost. SAS-C funding is intended to augment existing programs, providing more children with the opportunity to participate in cultural arts and science summer camps. Priority is given to projects that engage children whose ability to participate in such programs may be otherwise limited by geography, economics, or disability.

Background: The Children's Trust understands the importance of exposing children to visual arts, music, storytelling, and dramatic play. Since 2006, it has successfully partnered with the County to provide these experiences.

Research has demonstrated that involvement in the arts can enhance children's experiences in almost every social and academic standard of achievement. Furthermore, children who study art are generally happier, more self-confident, and more likely to academically outperform those who do not.

Match Funding and Funder Collaboration: Per the procurement policy, section 2006, Match Funding and Funder Collaboration, the negotiation and execution of a match contract is exempt from the competitive solicitation process. Renewal of match funding beyond the initial contract term is at the sole discretion of The Children's Trust and shall be contingent upon satisfactory performance evaluations, quality program results, outcome achievements, availability of funding, and an ability to maintain the underlying primary funding source(s). The County has consistently surpassed the minimum 100 percent funding match. Given the program's success, this resolution seeks to renew the match funding to expand arts programming across Miami-Dade County for another year. Attached is a summary of the progress for this match contract.

In addition, authorization for the President/CEO to move funds between the different QIS system components identified within this resolution, for a term of 12 months, commencing October 1, 2024, and ending September 30,

Budget Impact:

Funding in the amount of \$33,040,000.00 for this resolution is

projected to be available in FY 2024-2025.

Description of Services: The Thrive by 5 integrated child care quality improvement system (QIS) strives to increase access to high-quality early learning for young children in low-income neighborhoods. The QIS builds on prior Trust efforts, evaluation, board policy guidance, and the state's early learning quality improvement work. Using an equity lens, the OIS intervenes across systems to promote healthy development for children by helping to build twogenerational economic stability for families. The QIS offers a comprehensive array of supports for children and families, teachers, and child care programs, within an integrated system that takes a tailored and equitable approach to improve and maintain child care quality and ensure access to high-quality programs. The system has been intentionally designed, and each component is essential for the overall integrated approach to child care quality improvement. This interwoven and comprehensive array of supports amounts to more than the sum of the individual parts and functions as an interconnected system.

Licensed child care programs that meet the following criteria qualify to participate in the Thrive by 5 QIS.

- 1) 30+ percent of children under age 6 served receive Florida school readiness subsidies.
- 2) Located in a designated high-poverty Census area.
- 3) Provides services for infants and toddlers.

In 2018, with the rollout of the Thrive by 5 QIS, the components described below were newly designed, implemented, and integrated into a seamless system of supports aimed at assisting early learning providers to achieve and maintain high-quality care for children at greatest need.

Funded Program/Partners/System Component Descriptions

A\$CEND Salary supports for the early learning workforce [\$2,990,000.00]

In October 2022, The Children's Trust launched A\$CEND, the revamped salary supplement program. The program focuses on a more equitable design than the previous salary incentives model. Salary supplement programs help early learning programs in Miami-Dade County attract and retain more qualified practitioners. Higher practitioner wages are linked to teacher retention and staff stability, markers of high-quality child care. Children benefit from stable and trusting relationships with caregivers they know. Teacher and program director competency and stability are directly related to children's optimal development and learning gains. Preschools with highly qualified and well-paid teachers are better equipped to narrow the achievement gap. Due to a child care workforce shortage and low pay that has led to a child care crisis, this program supports teacher retention while incentivizing ongoing professional development.

During the 2022-23 contract year, 932 educators received salary supplement awards and the median award amount was \$1,750.00. Turnover among recipients was only five percent, compared with national average turnover rates for child care staff of 30 percent.

With the purchase order encumbered through this resolution, qualifying educators are paid directly by The Children's Trust. There is no contracted provider.

Early Learning Coalition of Miami-Dade/Monroe: Child care scholarships, high-quality tiered payment differentials, and educator scholarships

Child care scholarships [\$11,250,000.00]: The Early Learning Coalition manages the child care scholarship enrollment and provider payments to address early learning capacity issues in our community. Miami's significant oversaturation of the child care market, coupled with low payment rates for children receiving school readiness subsidies, pose significant challenges for providers to meet and maintain high-quality standards. The Thrive by 5 QIS offers guaranteed payment for slots in high-quality programs to serve children not otherwise served by the school readiness program. The Children's Trust Families Forward child care scholarships help children who become ineligible for a school readiness subsidy during the school year, and eligible families have incomes from 150 to 300 percent of the federal poverty level.

Currently, there are more than 1,390 children utilizing a Children's Trust Families Forward child care scholarship. There are more than 1,400 additional children on the waitlist.

High-quality tiered payment differentials [\$12,000,000.00]: Per chapter 1002.82(n), Florida Statutes, the Early Learning Coalition of Miami-Dade/Monroe

categorizes programs into quality tiers, from one to five (lowest to highest quality), based on Classroom Assessment Scoring System® (CLASS) assessments measuring teacher-child interactions. More than 200 studies demonstrate that children in classrooms with more effective teacher-student interactions, as measured by CLASS, have better social and academic outcomes, such as math, literacy, cognition, and classroom engagement. The Children's Trust investment leverages state dollars that fund the collection of CLASS assessments through this coordinated approach.

With the purchase order encumbered through this resolution, programs at quality tiers two and above receive payment differentials for all children ages birth to 5 years attending their program (not only those receiving school readiness subsidies). Early learning providers receive a payment differential according to their quality tier. The tiered payment differential is additional funding on top of the base school readiness subsidy rate.

For the 2023-24 contract year there are 333 early learning programs participating in Thrive by 5, and 220 of these are in tiers 4 or 5.

Educator Scholarships [\$1,000,000.00]: Educator scholarships will continue to be available to the more than 1,300 licensed child care programs in Miami-Dade County. These scholarships were previously managed by The Children's Forum. The Early Learning Coalition, in managing a newly developed Learning Management System and Professional Development Registry, will offer career advising services, scholarships for early learning educators and administrators, and ensures training and education received by practitioners are tracked. The Children's Trust seeks approval through this resolution to enter into a data sharing agreement with the Early Learning Coalition for the purpose of tracking educator professional development and award scholarships. Such information shall be used by The Children's Trust to determine strategic investments.

During the 2022-23 contract year with the Children's Forum, 908 educators applied for and received 1,586 professional development scholarships.

Funded Program/Partners/System Component Descriptions

United Way Miami: Formative child assessment [\$ 1,100,000.00]

The implementation of the Teaching Strategies GOLD® formative child assessment is supported by professional development and coaching for teachers and directors as they better individualize instruction for children based on the child's developmental level. Teachers conduct ongoing child assessments and analyze data to evaluate child knowledge, skills, and behaviors. These assessments also provide a means by which to track the development of children and assess the impact of the education they receive. To achieve successful implementation, it is critical that all center staff, including directors, participate in trainings and professional development opportunities.

United Way Miami provides the following services as part of the GOLD® implementation plan:

- 1. conducts phased rollout for early learning programs to include program readiness, a technological needs assessment, and cohort development;
- 2. creates professional development plans for GOLD® assessment coaches;
- 3. provides training for early learning educators;
- 4. offers ongoing on-site coaching and technical assistance;
- 5. manages data systems; and
- 6. develops data dissemination process and feedback loops.

During the 2022-23 contract year, the United Way Miami served a total of 73 early learning programs, inclusive of 576 educators and administrators working in 340 classrooms.

University of Miami Miller School of Medicine: Mental health consultation [\$3,000,000.00]

The University of Miami's Jump Start, Building Capacity through Partnership, is designed to support social and emotional development of children and to increase the capacity of early care providers to support the mental health needs and challenging behaviors that place children at risk for negative outcomes. Consultants help adults understand, assess, and address the needs of specific children exhibiting concerning behaviors by developing individualized plans with teachers and parents. They provide program-focused, classroom-focused, and child-focused consultations. Directors are supported by consultants to make changes in child care practices and policies. Teachers are supported by identifying the attitudes, beliefs, practices, and conditions that can undermine quality relationships between teachers and children.

The Children's Trust adopted the nationally recognized Georgetown model of Infant and Early Childhood Mental Health Consultation for providing support in school-based settings. The model was developed and evaluated by the Georgetown University Center for Child and Human Development with researchers and clinical experts across the country. It is an effective model to promote social-emotional development, address young children's challenging behaviors, and reduce preschool expulsions.

During the 2022-23 contract year, the Jump Start program served 116 programs, with an average of 22 consultation hours per classroom, and 440 sessions held with children and families.

Background: This initiative is grounded in the five guiding principles of a collective impact approach focused on developing a shared agenda, shared measurement systems, mutually reinforcing activities, continuous communication, and backbone support. The initiative uses a two-generation approach to promote healthy development to provide economic stability for families. System partners support ongoing quality improvement focusing on workforce development and sustainable businesses. Together, partners aim to build the capacity of locally responsive, high-quality early learning programs that meet the needs of children and families.

Thrive by 5 QIS continues to receive national recognition as an innovative and equity-focused approach to improve the quality and availability of high-quality early learning programs for young children who need it most. The model and its components have been featured in several national publications, and The Trust's work was elevated to the national stage. Staff was invited to present the A\$CEND program at the National BUILD conference in Los Angeles last November and will present on the Jump Start program this summer at a national conference in Washington DC.

Request for Procurement Waiver (requires the approval of a 2/3 vote of board members present): Because of the unique nature of the Thrive by 5 QIS and the carefully constructed and integrated system components, a formal competitive process is impractical and would take away from the progress made to date. A waiver is in The Children's Trust's best interest to improve quality early learning to benefit children in need. Each Thrive by 5 QIS component is an integral and interwoven part of the system. Since the 2018 launch, together with system partners and community stakeholders, each component has been intentionality refined to ensure the elements are connected, accessible, and equitable. The QIS has worked to create resilience in the Miami-Dade child care market. It would be disruptive to the system to break apart or redesign certain components of the whole.

The exception to the Procurement Waiver described above is for the Early Learning Coalition of Miami-Dade/Monroe (ELC). ELC is the entity responsible for determining eligibility and administering all state and federal childcare payments to early learning providers. As such,

per The Children's Trust's procurement policy section 2000. General Purchasing and Procurement Policy, Exemptions to Formal Competitive Procurement Process (G-4, single-source purchases), a competitive solicitation is not required.

Recommended Action: Authorization to negotiate and execute a contract with Florida

International University Board of Trustees, selected following a competitive solicitation for reading enhancement services, in a total amount not to exceed \$1,500,000.00, for a term of 12 months, commencing October 1, 2024, and ending September 30,

2025 with four possible contract renewals.

Budget Impact: Funding in the amount of \$1,500,000.00 for this resolution is

projected to be available in FY 2024-2025.

Description of Services: Since its inception, The Children's Trust has invested in many strategies to support early literacy development and reading skills. A key strategy of The Trust's reading efforts is to provide engaging reading education and supports in all Trust funded Youth Development (YD) after-school and summer programs. This is offered directly by funded YD providers and through a Summer Reading Explorers program (funded as a reading enhancement) offering differentiated literacy instruction (DLI) for rising kindergarten, first and second graders.

Reading enhancement services funding provided through this resolution is intended to increase the number of children in grades K-5 who read at or above grade level. It does so in the following ways:

- Increasing awareness of early literacy needs and science-based reading instruction through professional development for YD program staff and teachers, which may include online courses, live training, and on-site staff coaching/consultation.
- Increasing parent engagement in early literacy support and development, understanding reading skills measurement and intervention. This engagement will focus on parents and caregivers of K-5 students and may be offered through online courses, live workshops, and individual communications. Outreach is expected to be primarily through Trust-funded YD after-school and summer programs and may also leverage The Children's Trust Parent Club.
- Offering dyslexia screening and intervention services year-round in Trust-funded YD summer camps and after-school programs for rising K through fifth grade children.
- Reducing summer learning loss through DLI offered within Trust-funded YD summer camps and Trust-affiliated early childhood education programs for rising K, first and second graders.

The competitive solicitation included four required reading enhancement services to be funded, as summarized below:

1. Year-round professional development

- Direct professional development supports will include online courses, in-person and virtual live trainings, onsite reading staff coaching and consultation, peer learning supports, and content-related online resources. The focus will be on YD staff delivering high-quality reading supports to after-school and summer program participants.
- Community awareness and outreach to YD providers, Trust staff, families and the community.
- Planning and policy support involves ongoing data and policy analyses, content area expertise and guidance.
- o Trust Academy Collective partners will meet to ensure collaboration and connection among the partners offering resources to Trust funded providers.
- Use of the Trust Academy Learning Management System to track participation in professional development.
- Year-round parent engagement for parents of YD after-school and summer program participants will include topics related to early literacy development, reading skills measurement and interventions, dyslexia, and effective in-home support activities for struggling readers.
- Year-round dyslexia screening and intervention to identify and intervene earlier
 with children in YD after-school and summer programs who are experiencing signs of
 dyslexia and reduce the likelihood of persistent reading challenges.
- 4. **Summer Differentiated Literacy Instruction (DLI) screening and intervention** will support rising K, first and second graders in Trust-funded YD summer camps and Thrive by 5 early childhood education programs to reduce summer learning loss using evidence-based, small group DLI (no more than five children per group).

The paid partners will be offering various components of the activities listed above in a total amount from this award not to exceed \$488,901.00.

Background: As part of The Children's Trust efforts to reduce summer learning loss, reading enhancement services have been funded by The Children's Trust since 2013. During the second funding cycle, 2016-2018, the program was expanded to be year-round to include after-school staff coaching and consultation during the school year. This latest solicitation incorporated an additional component, year-round dyslexia screening and intervention, an essential need in Miami-Dade identified by the Miami-Dade County Grade-Level Reading Campaign, which The Children's Trust hosts.

Elementary students show significant needs which warrant the Trust's support of early literacy and reading services, especially among children growing up in economically challenged, fragile and otherwise marginalized families. In 2022, the portions of Miami-Dade County fourth graders scoring proficient or above on the National Assessment of Education Progress (NAEP) overall was 39 percent, with indications of significant disparities, as 21 percent of Black, 40 percent of Hispanic, and 64 percent of White students reached this achievement.

Resolution 2024-16, approved on November 13, 2023, directed staff to release an Invitation to Negotiate (ITN) 2024-11 to fund Reading Enhancement Services within The Trust's Youth Development (YD) after-school and summer programs. The solicitation was issued as an ITN

to allow the flexibility to negotiate with one or more responsive vendors with demonstrated expertise in reading education and intervention, especially when the desired services may not be of best value when provided by only one vendor, but rather by combining the strengths of multiple vendors into a coordinated effort.

The ITN was released on February 8, 2024. Two applications were submitted by the ITN deadline. Both were reviewed, and one application is recommended for funding.

- Staff recommendations: Taking into consideration the above review process results, consideration is also given to factors such as alignment with The Children's Trust's priority investment areas, effective and economical distribution of funding across Miami-Dade County and/or in underserved geographic areas/populations in Miami-Dade County (if applicable), minimizing duplication of efforts, and reasonable program cost for the services and outcomes proposed.

Background: The Children's Trust issued an Invitation to Negotiate (ITN) 2024-12 on February 8, 2024, to fund innovative projects and test new ideas that could lead to effective and equitable opportunities for vulnerable populations to help children thrive.

During this funding cycle, awards were capped at \$100,000.00 per successful application. The Children's Trust innovation team received and reviewed 125 pre-applications, of which 41 were invited to submit a full application. Thirty-one complete applications were submitted by the ITN deadline, all of which received an interview, and 21 applications are recommended for funding. This thorough process ensures the selection of the most promising projects. The comprehensive review process included:

Description of Services: Since its inception, The Children's Trust has invested in many strategies to support early childhood literacy development. To coordinate and expand upon these efforts, The Trust hosts the Miami-Dade County Grade-Level Reading (MDGLR) Campaign, which regularly engages more than 50 community partners to elevate literacy. A key strategy of The Trust's early literacy efforts is to increase access to books in multiple languages and accompanying enriching experiences for families of young children. This is accomplished through Books for Free, a program initiated in 2013, and The Children's Trust's other early literacy investments.

The Children's Trust Books for Free program ensures young children (through age 8) have access to books to take home and keep at no cost from bookshelves placed in public spaces throughout Miami-Dade County. Books are provided in English, Spanish, and Haitian-Creole and are obtained primarily through book donation drives and collection bins, which are part of Books for Free. The awarded Books for Free administrative agency has a 15 percent minimum annual match funding requirement, including cash or in-kind resources.

Books for Free requires an administrative agency with a keen understanding of literacy development and a passion for broadening children and families' access to books. This entails work engaging with communities, businesses, volunteers, and the public sector to:

- Collect, sort and categorize donated and purchased age- and content-appropriate, gently used and new books through book drives and other means.
- Distribute the books through stocked bookshelves maintained in public places where parents and children congregate for extended periods and through partnerships with community organizations, particularly in under-resourced neighborhoods throughout Miami-Dade County.

The competitive solicitation included four required activities to implement the Books for Free program, summarized below:

- **Administration** Management of and the logistics of all aspects of bookshelf maintenance, book donations/drives, participant and partner feedback, and family engagement aspects of the program. Administration also includes the required component of volunteer resources to support operations, and book purchase as needed that meet cultural and linguistic needs of Miami-Dade families.
- **Book Drives and Donations** The acquisition of new and gently used books to fill distribution bookshelves that are age appropriate and reflect the diverse population of Miami-Dade County through outreach strategies, book drives, and donations from business and other appropriate locations. This also includes repurposing returned and undelivered books from The Children's Trust Book Club.
- **Bookshelf Maintenance and Expansion** Maintain and expand upon the 76 current Books for Free bookshelf locations to 116 locations. Bookshelf locations in public spaces provide access for families to take free books. Activities include developing relationships with community partners at site locations to ensure shelves are regularly well stocked and maintained.
- **Reading Circles** Host family engagement activities at least once a month to promote Books for Free program awareness and to foster a love for reading. Reading circles may provide opportunities for authors, performers, and/or students to demonstrate the richness of literacy experiences, as well as attend community-based events to promote the program, such as health fairs, children's events, library events and festivals, including The Children's Trust Family Expo.

Budget Impact: Funding in the amount of \$1,700,000.00 is projected to be

available in FY 2024-25.

Description of Services: Regardless of their circumstances, all parents and families face inevitable parenting challenges and can benefit from learning research-informed strategies that support children's healthy development. Effective, consistent, and supportive parenting prepares children for a lifetime of success. Brief universal parenting workshops and supports can offer an effective, low-cost way to reach large and diverse groups of primary caregivers who might not otherwise receive parenting education. Improved parenting will support positive child outcomes related to emotional, behavioral, social and cognitive competence, and physical health and safety.

The Children's Trust Parent Club was launched in September 2019. Brief, evidence-based parenting workshops are delivered for free in English, Spanish, and Haitian Creole for diverse groups of primary caregivers across Miami-Dade County to build knowledge and skills. Topics cover a range of age-appropriate content about raising children who are successful, healthy and happy. These group contacts among parents also strengthen social supports by connecting parents and linking families who have additional needs with appropriate services. Parent Club universal workshops and supports can be an entry point to more intensive parenting and family strengthening services funded by The Trust for selective and indicated populations across the parenting continuum of care.

The goal is to reach Miami-Dade parents and caregivers to increase their awareness and engagement in effective parenting strategies that support child development. The minimum number of parents and caregivers to be served by each contracted agency is 4,500 annually, with at least 80 percent of workshops to be delivered in person.

The Parent Club Handbook guides the Children's Trust Parent Club. All Parent Club contracted providers use standard activities and implementation procedures, common branding, and messaging to maintain consistency and quality. There is active coordination among all Parent Club providers to ensure consistent universal parenting messaging organized activities, and prominent co-branding.

There are five required activities, listed below, and one agency is recommended to deliver the optional activity to function as the Parent Club Coordinating Agency.

- 1. Parent Workshop Delivery
- 2. Content Development
- 3. Referral Linkages
- 4. Community Outreach Events
- 5. Coordination Meeting Participation

The recommended Coordinating Agency noted below will work collaboratively with The Children's Trust and all funded Parent Club providers. They will be responsible for various Parent Club development, administrative and program support tasks to ensure consistency and quality of program implementation across the initiative. A dedicated full-time management staff member manages and executes the coordinating agency's responsibilities.

Background: The Children's Trust issued a Request for Proposals (RFP) 2024-13 on March 20, 2024, to fund multiple entities to implement The Children's Trust Parent Club, for brief, evidence-based parenting workshops, delivered free in English, Spanish, and Haitian Creole to diverse groups of primary caregivers across Miami-Dade County to build knowledge and skills, for a five-year cycle with one-year contract renewals.

More than 3,700 parents and caregivers of children and youth of all ages completed our online parent community survey to inform the development of this solicitation. In addition, The Trust conducted 16 focus groups with more than 100 parents in English, Spanish, and Haitian Creole. Participants included fathers, mothers, alternative caregivers, teen parents, expecting parents, biological and alternative caregivers involved in the dependency system, parents of

Recommended Action: Authorization to negotiate and execute a contract renewal with Q-

Q Research Consultants, LLC for research and evaluation services, in a total amount not to exceed \$185,000.00, for a term of 12 months, commencing on October 1, 2024, and ending September

30, 2025.

Budget Impact: Funding in the amount of \$185,000.00 for this resolution is

projected to be available in FY 2024-25.

Description of Services: As part of The Children's Trust funding requirements, The Trust collects and analyzes extensive data relating to the demographics and attendance of the families and children served through the Trust-funded programs ("program participants"), the quality of programs delivered, and the outcomes achieved by program participants. This resolution seeks to incorporate additional, timely feedback from potential, and existing program participants to assess program participant needs, input and satisfaction regarding The Children's Trust-funded programs. The goals are two-fold:

- 1. Strengthen The Children's Trust's understanding of potential program participants' needs and interests as we plan for future investments.
- 2. Incorporate input and satisfaction feedback from current program participants to guide The Children's Trust and funded program providers' continuous learning and quality improvement efforts.

Projects for the 2024-2025 fiscal year will vary in purpose and population to meet the planning needs of The Children's Trust. The work will continue to center around research and evaluation services to inform program participant needs, input, and satisfaction with Trust-funded programming. Health and wellness planning is expected to continue in the new fiscal year. The Children's Trust Book Club will require parent input through focus groups to inform the new funding cycle and associated competitive solicitation to be released next year. Other potential areas for participant input relate to special populations, family stabilization and other supports.

Any focus groups, interviews, or surveys with participants will be conducted in English, Spanish and Haitian Creole. When appropriate, the budget includes participant research incentives for data collection. Mixed methods will be incorporated to triangulate input (i.e., enhancing survey results with focus group input or other relevant comparative community population or indicator data points). Results will support sound decision-making about future investments in programs and services for children and families. Sampling will ensure representation of all major race/ethnicity and language groups in Miami-Dade County, as well as oversample families earning less than half the median household income for the county, when appropriate.

Background: Q-Q Research Consultants, LLC designed and conducted a community-level parent survey in late 2022 to understand program participant needs. Areas of focus included early child care, after-school and summer programming, parenting supports, health and development services, and demographics. Initially, a survey dashboard was used to track responses and guide outreach to ensure the sampling goals were met, and they were. The final parent sample includes nearly 3,500 parents, ranging from expecting parents to parents of adolescents. In 2023, four executive summary participant input reports were published and posted on The Children's Trust website. In 2024, survey results dashboards were developed for internal use to facilitate data exploration, which informed solicitations and is expected to continue to inform solicitations and initiative development planning in coming years.

Additionally, in the 2022-23 fiscal year, Q-Q Research Consultants, LLC successfully conducted and analyzed input from numerous focus groups across all regions of the county, with a focus on special populations such as children with significant disabilities, youth and families involved in the child welfare and delinquency systems, fathers, expecting parents, teen parents, parents of LGBTQ+ children, and immigrant families. To inform the youth development solicitation, they conducted 27 focus groups with 101 parents and 61 youth attending Trust summer camps and another 28 youth who were not actively in school or working, to provide input about what they want in programming. They further conducted and summarized 16 focus groups with more than 100 parents to inform the parenting and family strengthening solicitation and the Parent Club solicitation. Finally, in the fall of 2023, as part of our ongoing school-based health strategic planning, they conducted and compiled 23 focus groups/ interviews with 136 parents, youth, nursing staff, mental health and social work staff, school health provider administrators, and systems partners at Miami-Dade County Public Schools and the Florida Department of Health in Miami-Dade County.

In the current fiscal year, Q-Q Research Consultants, LLC supported the joint development of our Trust provider staff survey regarding their satisfaction with program quality supports and resources offered by The Children's Trust and Trust Academy partners. They administered the online survey in English, Spanish and Haitian Creole, collecting and analyzing more than 1,200 survey responses. This provider feedback is critical for The Trust's and Trust Academy's continuous learning and quality improvement.

On April 6, 2022, The Children's Trust released a Request for Proposals (RFP) 2022-05, which closed on April 22, 2022. Four applications were received by the deadline and reviewed according to the solicitation guidelines and procurement policy. Based upon the reviews, Q-Q Research Consultants, LLC was recommended to carry out the research and evaluation services being sought. On May 16, 2022, the board approved resolution #2022-51 to fund the first 17 months of research and evaluation services (considered year one). The following year, the contract was renewed for a second year. The current resolution seeks the 12-month renewal for year three of services.

At year three, The Trust will assess the continued need for services and vendor performance to determine the need to renew for up to two additional 12-month terms, for a cumulative total of five years of funding. The option to renew a contract shall be at the sole discretion of The Children's Trust.
